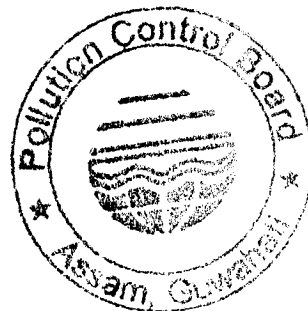

Terms and Conditions of Authorization

1. The authorization shall comply with the provisions of the environment (Protection) Act, 1986 and rules made there under from time to time.
2. The authorization or its renewal shall be produced for inspection at the request of an Officer authorized by the Pollution Control Board, Assam.
3. M/s. Assam Roofing Limited (Asbestos Unit), Bonda, Narangi, Guwahati-781026, Kamrup, Assam shall not rent sell, transfer or otherwise transport the hazardous waste without obtaining prior permission of Pollution Control Board, Assam Disposal shall be done to the authorized units only to which Pollution Control Board, Assam has issued authorization. They should submit agreement/receipt copies from the authorized vendors for disposal of Hazardous Wastes so far made within one month of issuing of this Authorization.
4. Any unauthorized change in personnel equipment as working conditions as mentioned in the application by the person authorized shall constitute a breach of this authorization.
5. It is the duty of the authorized person, M/s. Assam Roofing Limited (Asbestos Unit) to take prior permission of the Board to close down the facility.
6. An application for the renewal of an Authorization shall be made as laid down under these rules.
7. Any other conditions for compliance as per the guidelines issued by Ministry of Environment & Forests or Central Pollution Control Board.
8. Other terms & conditions as per the Authorization issued vide letter No. WB/OTWA/HW-03/01-02/119 dtd. 03.08.2011.
